A full and final release and waiver of liability of the program organizer and all persons and organizations, agents and/or employees, other participants, sponsors, advertisers, owners, and/or leasers of the premises used to conduct the program, sanctioning bodies, medical or rescue personnel (The RELEASES), of and from the respect of all injury, disability, death or loss or damage to person or property whether arising from the negligence, or negligent rescue by the foregoing or otherwise and,

An UNDERSTANDING NOT TO SUE THE RELEASES for any loss, injury, cost, or damages of any form or type, however caused or arising, and whether directly or indirectly from the participation of my minor child/ward in the program, and

An agreement to indemnify, and to save and hold harmless the releases, and each of them, from any litigation expense, legal fees, liability, damage, award or cost, of any form or type whatsoever, they may incur due to any claim made against them or any one of them whether the claim is based on the negligence or the gross negligence of the RELEASES or otherwise.
